**NOTES TO APPLICANTS 申請人須知**

- 1) To be eligible for exemption for the Sports-General Theory (Part A) Course, applicants should have successfully completed the relevant courses (attached) within the last five years.  
申請人須於過去五年內修畢有關課程(見附頁)，方可獲得豁免修讀運動通論(甲部)課程考慮。
- 2) Applicants are required to complete the application form (ExForm/07) and send together with certified true copies of documentary evidence of relevant qualifications (e.g. Certificates, Official transcripts, etc.), a non-refundable administration fee of \$200 and one photo of 1.5"W x 2"H (blue background) taken within recent 3 months to the Coach Education Department for processing.  
申請人須填妥申請表格(ExForm/07)，連同有關學歷證明文件之認證副本(如：證書/文憑、成績單等)、不可退還之行政費\$200及3個月內之近照1張(藍底)，尺寸須為1吋半(闊)乘2吋(高)寄交至教練培訓部審理。
- 3) Applications will be assessed according to the information submitted. Applicants will normally be notified of the result of their application within two months from the date of receipt of the full set of information required for the application by the Coach Education Department.

- 4) **For courses which are not included in the eligible course list**, application will be considered on a case-by-case basis. Detailed syllabus should be sent along with the application form (ExForm/07) and certified true copies of documentary evidence to the Coach Education Department for assessment. A non-refundable administration and assessment fee of \$500 will be charged.
